- (3) alternatives to campus police- discussion: Turning Point, apparent police priority of property over human life, SSU police not willing to escort students (even from remote areas like the Art building which is near the creek area where attempted and actual assaults have happened). It would be powerful to hear from students. The history of policing originates in slavery. Rohnert Park & Cotati police departments would still be there in the event of the abolition of SSU campus police. Police are expensive (paid partially by student fees) and that money could go to mental health counselors.
