



## **Legislative Update: Sponsored/Co-Sponsored Legislation May 5, 2023**

### **INTRODUCTION**

The CFA is sponsoring or co-sponsoring eight (8) pieces of legislation during the first year of the 2023-2024 biennial legislative session. Six (6) of those bills passed out of the policy committees in the house of origin by the April 28, 2023 legislative deadline. Two (2) of the CFA's sponsored/co-sponsored bills were made into two-year bills at the request of the authors. Below are summaries of CFA's sponsored/co-sponsored bills with their current status.

### **CFA Sponsored Bills**

- **California Student Teacher Support Grant Program: Assembly Bill 238 (Muratsuchi)** expresses the intent of the Legislature, to improve teacher retention and recruitment in California's public school system, to create a grant program to compensate student teachers to help alleviate financial stress at an important time in the teacher preparation process. In addition, the bill would, contingent upon an appropriation of one-time funding, establish the California Student Teacher Support Grant Program, under the administration of the Commission on Teacher Credentialing (CTC), to award grants of an unspecified amount to teaching credential candidates to compensate them while they perform the required 600 hours of student teaching. Finally, the bill would require that stipends for each student teacher to be equal to the daily substitute teacher pay rate.

#### **Position: Sponsor**

**Current Status: AB 238 passed out of the Assembly Education Committee on April 12, 2023 on a consent vote. Subsequently, the bill was placed on the Assembly Appropriations Committee Suspense File on May 3, 2023.**

- **Teacher Credentialing Task Force: Assembly Bill 672 (Jackson)** would require the Commission on Teacher Credentialing (CTC) to convene a Teacher Credentialing Task Force by March 1, 2024 comprised of teacher educators from each segment of the higher education system, students in teacher credentialing programs, organizations representing university faculty, teachers and administrators, to examine, among other things, the available research on the factors that enable and constrain recruitment, credentialing and retention of a diverse teaching workforce and the experiences of student candidates in various credentialing pathways, and to report to the appropriate committees of the

Legislature on or before March 1, 2027 on any recommendations based on those findings for increasing the number of, and diversity of, qualified teachers in California.

**Position: Sponsor**

**Current Status: AB 672 passed out of the Assembly Education Committee on April 12, 2023 on a 7-0 vote. Subsequently, the bill was placed on the Assembly Appropriations Committee Suspense File on May 3, 2023.**

- **Parental Leave for California State University (CSU) Employees: Assembly Bill 1123 (Addis and Cervantes)** This bill would require the CSU to provide one semester of paid parental leave to employees, as defined in subdivision (e) of Section 3562 of the Government Code, in each one-year period. Such leave would be taken consecutively, unless mutually agreed upon otherwise by the employee and the appropriate administrator. Such leave would be charged only for workdays in such a period of time and may be used for reasons of the birth of a child of the employee or the placement of a child with an employee in connection with the adoption or foster care of the child by the employee.

**Position: Sponsor**

**Current Status: AB 1123 passed out of the Assembly Higher Education Committee on April 11, 2023 on a 9-2-1 vote. Subsequently, the bill was placed on the Assembly Appropriations Committee Suspense File on April 26, 2023.**

- **Ethnic Studies Credentialing Task Force: Assembly Bill 1255 (Carrillo)** This bill would require the Commission on Teacher Credentialing (CTC) to convene a statewide Task Force beginning March 1, 2024 comprised of the major stakeholder groups to develop recommendations for the creation of a single-subject Ethnic Studies credential for teachers. The Task Force would be required to issue a report on the requirements for the development of a single-subject Ethnic Studies credential by September 2024 to be submitted to the Commission on Teacher Credentialing and the Legislature. Finally, the bill would require the Commission on Teacher Credentialing to begin the development of the single-subject Ethnic Studies credential by January 1, 2025.

**Position: Sponsor**

**Current Status: AB 1255 was scheduled to be heard in the Assembly Education Committee on April 12, 2023 but was pulled by the author to continue work on the bill. The bill will now become a two-year bill.**

- **California State University (CSU) Mental Health Services: Senate Bill 11 (Menjivar)** This bill would require the CSU to have one full-time equivalent California-licensed counselor for every 1,500 students on each campus. In addition, SB 11 would require the CSU on or before January 1, 2025, and every three years thereafter, to report to the

Legislature how money was spent, the number of mental health counselors employed on each CSU campus and student wait times for mental health counseling appointments. SB 11 would also require the CSU on or before November 1, 2024, and every three years thereafter, each campus to conduct a campus survey and focus groups, including groups with students of color and LGBTQ+ students, to understand student needs and challenges about their mental health and emotional well-being, sense of belonging on campus and academic success. Finally, SB 11 would provide grants to the CSU to support recruitment efforts for students to enroll in graduate degree programs that lead to licensure by the Board of Psychology or the Board of Behavioral Sciences to practice mental health counseling in the state of California and provide paid internships for these students.

**Position: Sponsor**

**Current Status: SB 11 passed out of the Senate Education Committee on March 29, 2023 on a 7-0 vote. Subsequently, the bill passed out of the Senate Health Committee on April 27, 2023 on a 10-0-2 vote. The bill now moves to the Senate Appropriations Committee.**

**CFA Co-Sponsored Bills**

- **Public Postsecondary Education Hate Crimes Surveys: Assembly Bill 644 (Jones-Sawyer)** would require the Chancellor of the California Community Colleges (CCC) and the Chancellor of the California State University (CSU), and request the President of the University of California (UC), to develop a survey on campus climate related to hate crimes to be submitted to the United States Secretary of Education for review and approval to be incorporated into an online survey tool for campus safety. In addition, the bill would require campuses that already have formulated and implemented a campus climate survey before January 1, 2024, to meet on or before December 31, 2024, and at least once every 5 years thereafter, to review and update the survey with student participation in the development of the survey questions. AB 644 would also, beginning one year after the date the online survey is made available, require that the CCC and CSU, and request that the UC, to submit a report to the Assembly Committee on Higher Education and the Senate Committee on Education. Finally, this bill would require these reports to be posted on the website on each campus.

**Position: Co-Sponsor**

**Current Status: AB 644 was referred to the Assembly Higher Education Committee but was pulled by the author to continue work on the bill. The bill will now become a two-year bill.**

- **Divestment from Fossil Fuels: Senate Bill 252 (Gonzalez, Stern and Wiener)** would prohibit the boards of the Public Employees' Retirement System (CalPERS) and the State Teachers' Retirement System (CalSTRS) from making new investments or renewing existing investments of public employee retirement funds in a fossil fuel company. The

bill would require the boards to liquidate investments in a fossil fuel company on or before July 1, 2030. The bill would provide that it does not require a board to take any action unless the board determines in good faith that the action is consistent with the board's fiduciary responsibilities established in the California Constitution. This bill would require the boards, commencing February 1, 2024, and annually thereafter, to file a report with the Legislature and the Governor, containing specified information, including a list of fossil fuel companies of which the boards have liquidated their investments. The bill would provide that board members and other officers and employees shall be held harmless and be eligible for indemnification in connection with actions taken pursuant to the bill's requirements.

**Position: Co-Sponsor**

**Current Status: SB 252 passed out of the Senate Labor, Public Employment and Retirement Committee on April 12, 2023 on a 4-1 vote. Subsequently, the bill passed out of the Senate Judiciary Committee on April 18, 2023 on an 8-2-1 vote. The bill was placed on the Senate Appropriations Committee Suspense File on May 1, 2023.**

- **California State University Terms of Employment: Settlements and Retreat Rights: Senate Bill 808 (Dodd)** would require the rules adopted by the trustees of the California State University to among other things: (1) require each campus president and either a vice president or vice chancellor to approve all sexual harassment settlements, (2) require a report to the Chancellor's office and the Legislature on the number of sexual harassment complaints filed, the length of time taken to complete the investigative process and the disposition of those cases and (3) prohibit retreat rights for any campus president, provost or other senior administrator who has violated any California State University or campus Title IX policy from being entered into on or after January 1, 2024 or upon the expiration of a conflicting memorandum of understanding that was in effect before January 1, 2024, whichever is later.

**Position: Co-Sponsor**

**Current Status: SB 808 passed out of the Senate Education Committee on March 29, 2023 on a 6-0-1 vote. Subsequently, the bill passed out of the Senate Judiciary Committee on April 26, 2023 on a consent vote. The bill now moves to the Senate Appropriations Committee.**
