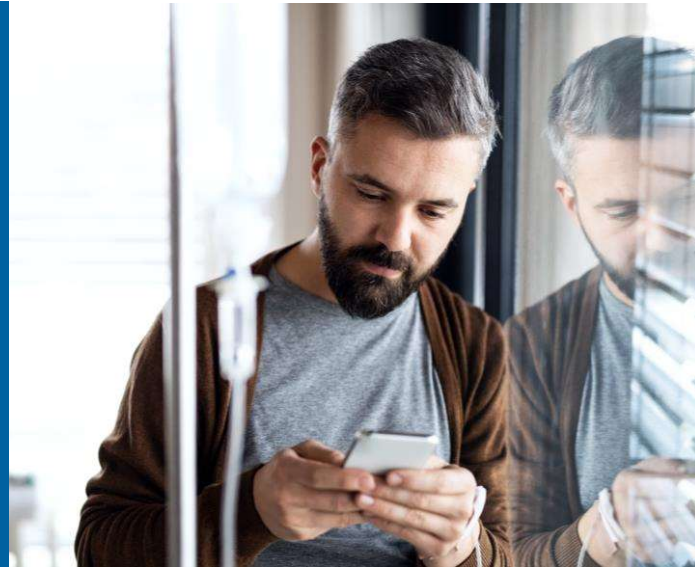

### Hospital indemnity insurance: Why is it important?

Hospital<sup>1</sup> stays can be pricey and are often unexpected. Since most healthcare plans don't cover all expenses, taking steps to help protect yourself can make a big difference.

Studies show that the average cost of a three-day hospital stay in the U.S. is \$35,000,<sup>2</sup> so hospital indemnity insurance makes good financial sense.

While in the hospital, you'll likely need various treatments, tests and therapies to get up and about again. These services can result in out-of-pocket costs beyond what your medical plan may cover—in addition to deductibles, copays and expenses that come with out-of-network care.

### How it works

Hospital Indemnity Insurance is coverage that can help safeguard your finances by providing you with a lump-sum payment—one payment all at once—when you or your loved ones need it most. The extra cash can help you focus on getting back on track without worrying about finding the money to cover treatment costs. A flat amount is usually paid for a hospital admission and a per-day amount for your entire hospital stay.

Best of all, the payment is made directly to you regardless of any other insurance you may have. It's yours to spend however you like, including for everyday living expenses.

There may be a preexisting condition limitation for hospital sickness benefits. MetLife's Hospital Indemnity Insurance may be subject to benefit reductions that begin at age 65. Like most group accident and health insurance policies, policies offered by MetLife may contain certain exclusions, limitations and terms for keeping them in force.
