## Resolution for California Faculty Association (CFA) to Join American Federation of Teachers (AFT) Lawsuit for Public Service Loan Forgiveness

Whereas, Public Service Loan Forgiveness (PSLF) is a federal program for people who work full time in the public sector or for certain non profit organizations;

Whereas, PSLF has been identified as a recruitment and retention mechanism to attract talented individuals who seek a career in public education, health care, and countless other professions;

Whereas, tens of thousands of California State University (CSU) Bargaining Unit 3 faculty and staff employees have earned loan forgiveness by dutifully performing 120 months of service while consecutively paying their debt off;

Whereas, CSU Bargaining Unit 3 employees earn significantly less than their peers in the private sector;

Whereas, the President of the United States Donald J. Trump has sworn to the dismantling of the Department of Education which aligns with Project 2025;

Whereas, politically motivated lawsuits have halted PSLF borrowers on the SAVE plan from earning credit due to court injunctions;

Whereas, Secretary of Education Linda McMahon has publicly stated she wants to dismantle the US Department of Education;

Whereas, 1.8 million member American Federation of Teachers (AFT) have filed a lawsuit against the US Department of Education;

Whereas, in said lawsuit the AFT identified that the US Department of Education has violated the law by removing incoming driven repayment (IDR) plan applications options from its website;

Whereas, the removal of IDR plans by default places borrowers on standardized 10 year plans that are unreasonably high given the amount of high debt among students;

Whereas, CFA recognizes that without IDR plans Bargaining Unit 3 employees could be forced to choose between health care, housing, and/or basic necessities in order to pay monthly student loan payments;

Whereas, CFA is a member of the American Association of University Professors (AAUP) which holds an affiliation with AFT;

Whereas, CFA recognizes that IDR plans were established to earn credit towards the completion of 120 month minimum while consecutively paying off student loans;

Whereas, CFA has a mutual interest in protecting its 29,000 faculty member union who are PSLF loan borrowers;

Resolved, CFA members will not tolerate predatory lending practices by US President Donald Trump and Secretary of Education Linda McMahon that exploit the goodwill of public servants;

Resolved, CFA members stand united and in solidarity with the American Federation Teachers Union;

Resolved, CFA members recognize the importance to uphold the Public Service Loan Forgiveness Act of 2007 in courts;

Resolved, CFA will pursue legal avenues to join the aforementioned lawsuit against Secretary Linda McMahon and US President Donald Trump to ensure compliance with the Public Service Loan Forgiveness Act (2007);
