**1 Whereas**, The CFA is a union of faculty with diverse ethnicities, national origins, and political and religious views, united in defending universal human rights, including the right to education and freedom of speech and has previously passed <u>CFA RESOLUTION TO SUPPORT PALESTINIANS AND THEIR ALLIES IN THE</u> <u>CALIFORNIA STATE UNIVERSITY</u> (Spring 2024) and <u>CFA RESOLUTION TO FUND JOBS AND EDUCATION, NOT</u> <u>WARS AND OCCUPATION</u> (Fall 2024);

**2** Whereas, many of our faculty and students are directly and indirectly impacted by injustices of settler colonialism in Palestine based on occupation, ethnic cleansing, apartheid, and genocide;

**3** Whereas, Palestinian students, staff, and faculty are routinely subjected to oppression, arrest, torture, and in many cases, murder at the hands of the Israeli armed forces and violent settler groups;

**4 Whereas,** the Israeli government has carried out "systemic destruction of the Palestinian education system"<sup>1</sup> including bombing all universities and the majority of schools in Gaza, "an action known as 'scholasticide;"<sup>2</sup>

**5** Whereas, Israel is intensifying acts of scholasticide in all of occupied Palestine;

**6 Whereas,** according to the International Court of Justice (ICJ) Israel's war on Gaza "appears to be capable of falling within the provisions of the Genocide Convention,"<sup>3</sup> and Israeli policies in Palestine "violate the prohibition on racial segregation and apartheid;"<sup>4</sup>

**7 Whereas**, Israeli universities have been an integral part of state militarism and armament industries, and their connections with military and intelligence entities have been widely documented<sup>5</sup>;

**8** Whereas, Israeli universities collaborate with the government in oppressing and discriminating against Palestinians, including Palestinian students and faculty;

**9 Whereas**, Israel subjects Palestinian-American students and faculty to discriminatory treatment and restrictions on travel to educational institutions which they are eligible to attend through CSU study abroad programs (CSUIP);

**10 Whereas**, The University of Haifa, the chosen site for the CSUIP in Israel, is collaborating with Israeli armed forces and houses special programs for training high-ranking military personnel<sup>6</sup>;

**11 Whereas,** the AAUP recognizes that academic boycotts are consistent with principles of academic freedom and are "legitimate tactical responses to conditions that are fundamentally incompatible with the mission of higher education;"<sup>7</sup> and

**12 Whereas,** The CSUIP partnership with Israeli universities and other institutions makes the CSU complicit in Israeli discriminatory policies; therefore be it

**1 Resolved**, that the CFA Board of Directors demand that the CSU immediately and permanently terminate any study abroad program (CSUIP) in Israel, and be it further

**2 Resolved**, that the CFA Board of Directors demand the immediate termination of any CSU collaboration and partnership (including but not limited to signed MOUs) with Israeli universities and academic or cultural institutions due to their complicity in occupation, ethnic cleansing, apartheid, and genocide.<sup>8</sup>
