COMPLAINT

It having been charged by Charging Party that Respondent engaged in unfair practices in violation of Government Code section 3571.1, the General Counsel of the Public Employment Relations Board (PERB), pursuant to Government Code sections 3563(h) and 3563.2 and California Code of Regulations, title 8, section 32640, issues this COMPLAINT on behalf of PERB and ALLEGES:

- 1. Charging Party is an employer within the meaning of Government Code section 3562(g).
- 2. Respondent is an exclusive representative within the meaning of Government Code section 3562(i) of an appropriate unit of employees. Respondent represents a unit of faculty members working for Charging Party.
- From approximately October 2024 to at least approximately April 2025,
 Respondent and Charging Party were meeting and conferring pursuant to Government
 Code section 3570.
- 4. Before approximately March 2025, the status quo concerning the parties' ground rules for collective bargaining negotiations was that employee observers were not permitted to attend negotiations.

5. On or about March 29, 2025, Respondent changed this policy by bringing

employee observers to a bargaining session with Charging Party.

6. Respondent engaged in the conduct described in paragraph 5 without prior

notice to Charging Party and without having afforded Charging Party an opportunity to

meet and confer over the decision to change the status quo and/or the effects of its

decision to do so.

7. By the acts and conduct described in paragraphs 5 and 6, Respondent

failed and refused to meet and confer in good faith in violation of Government Code

section 3571.1(c).

8. In addition, under the totality of circumstances, including but not limited to

the specific acts described in paragraph 5, Respondent failed and refused to bargain

in good faith with Charging Party in violation of Government Code section 3571.1(c).

Any amendment to the complaint shall be processed pursuant to California

Code of Regulations, title 8, sections 32647 and 32648.
